The purpose of this letter is to comment on the proposal for a garage and secondary dwelling at 17 Fox St. We are secondary dwelling.

Having consulted the Development Plan 2010 Section 3.3.2 – secondary dwellings on rear lanes - we note the plan is silent with respect to balconies in loft additions.

However we draw your attention to the following:

C2 - Any residential or habitable accommodation is to be above the footprint of the ground floor garage.

C3-The residential or habitable accommodation is to be in the form of a loft addition set into the roof space.

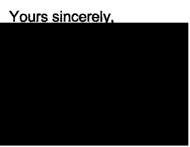
We are concerned the balcony as proposed protrudes beyond the roof space <u>and</u> extends beyond the footprint of the ground floor garage. As such we question whether it complies with controls C2 and C3.

Our objections are as follows:

•	Plans for the proposed two-story dwelling include a balcony which will provide

- We are concerned about protecting our privacy. The sight lines of the proposed balcony look
- While we note a timber privacy screen on the proposed plans we are concerned that the balcony is sufficiently wide to allow almost full views of the
- Our request is that the balcony is removed from the plans altogether.
- Alternatives to the removal of the balcony could be the extension of the privacy screen to
 entirely screen the views from the balcony
 significantly minimise the line of sight.
- In addition, we request that a survey is undertaken on the land to establish the exact site
 boundary. We are doubtful that the current garage sits exactly on the boundary, yet it is
 reflected as such in the proposed plans. Given the relatively small block sizes and the height
 and scale of the proposed garage it is our preference that the garage is set back and not
 sited exactly on the site boundary at '0' as is proposed.
