Councillor D Hayes advised of a reserve that connects Darri Street to Karoom Drive and Nara Place in Glenfield that people use to head to South City. It comes out in Darri Street along about 100m of units. Residents have complained that pedestrian traffic on private property causes concern along the units and were wondering if a barrier can be installed and if so, whether that is council's responsibility or the landowners?

Councillor D Hayes has been liaising with a number of young people in Wagga, the use of existing areas and facilities in different ways was discussed. One thing from those discussions is at the Victory Memorial Gardens there is no tables in lit areas including under the light tree, only seats. Is there a reason for this? Or can we look at this happening?

Councillor D Hayes advised on the 28th September 2020, Council approved a plan to look at addressing social and community advantage in that report Council committed to a range of tasks and focus areas. Councillor D Hayes requested an update of each of those areas and what we have achieved and not yet met? For example, reviewing the level of service of parks maintenance and the classification system.

Councillor R Foley requested we look into Canterbury Bankstown Council's fleet of garbage trucks that has been fitted with cameras in a state-first ploy designed to detect road damage. It would assist with Road Audits and show ongoing damage and pick up new pot holes. Minister for Customer Service Victor Dominello said the government is working with councils such as Wollongong and Liverpool to roll out the technology. Would this be a viable option for Wagga to reduce the number of pot holes we have throughout the Local Government Area?
