## **QUESTIONS WITH NOTICE**

### **QWN-1 - MARSHALLS CREEK BRIDGE DEVELOPMENT**

Councillor Richard Foley enquired about the diversion of B Doubles whilst work is carried out on the Marshalls Creek Bridge development.

The Director Infrastructure Services advised there is only expected to be about 20 nights that the Sturt Highway will be closed and the detour will be via Eunony Bridge Road, Byrnes Road, Merino Road and the Olympic Highway for heavy vehicles and Koorringal Road, Copland Street, Sutton Street and Nagle Street will be the detour for light vehicles .
