I have owned my property since 1982, I have both Sycamore and Grevillea Cres storm water drainage canal meeting in my property then continuing through as the Kooringal drainage, hence onto Marshalls Creek. My wife and I would like to object to approval of this development control plan for the following reasons. This proposal will introduce a lot more stormwater runoff into the already overloaded and poorly maintained Sycamore Drain. Houses in Sycamore Road have already been flooded on at least 3 occasions that we know of due to Council's unwillingness or lack of ability to properly maintain the Sycamore drain and the drainage system/retention basin in Rawlings Park which feeds into the Sycamore drain. The majority of the drainage channels in Rawlings Park are overgrown with vegetation and littered with fallen timber. A large tree fell into the drain near the effluent dam in Rawlings Park in November 2020 and still has not been removed by Council. We have lived in Sycamore Road for more than 30 years and in this time Council have only done work in the Sycamore Drain on one occasion. All this work achieved was to leave the Sycamore Drain in a worse condition than before the work was carried out with large unsightly piles of dirt and rubbish on my property. I hope that if Council ever get around to carrying out maintenance on the Sycamore Drain they will be a bit more professional and clean up after themselves. I write in regards to Draft Planning Proposal LEP 19/0010 – Wagga Wagga LEP & Development Control Plan 2010.

The intent of this amendment to the LEP & DCP is to reduce lot sizes in the area bordered by Mitchell, Brunskill, Silverwood and Birch Rd for the purpose of subdividing this land into a residential subdivision (Lake Albert Heights).

I have concerns in relation to aspects of and information provided to Council in relation to the planning proposal. Of foremost concern is the current infrastructure capacity to deal with stormwater run off from this proposal.

The infrastructure report by Lance Ryan Consulting Engineers provided as part of the proposal makes several statements and assertions about the likely effect of the development on stormwater flows and discharges. Most of this commentary revolves around controlling and retaining stormwater flows to pre development flow levels and rates. Whilst it is likely these assertions and comments are made with no prejudice I fail to see how they could be accurate. There is no data provided by the infrastructure report as to current or future likely stormwater flows that support the assertions made in the report. There is no mention in the proposal as to the maximum size of dwellings or outbuildings that will be permitted on each lot and as such accurate assessment of stormwater run off and its resultant effects in my opinion has not been adequately addressed.

This point is further supported in writing by Council's own officers. In an email dated the 5 February, 2019 from Council's Development and Subdivision Engineer, Keith Seegers writes,

"A stormwater study would need to be carried out to determine the impact of the development on stormwater flow in the creek as it is subject to overland flow flooding."

I can find no reference in the documents supplied to Council of any stormwater study or hydrology study having been carried out or supplied to Council. Verbal contact with Council's point of contact in relation to this matter indicated that this report had not been supplied.

With the lack of this expert evidence or assessment I am of the opinion that Council is making a decision on this proposal without sufficient probity and due diligence as to the likely effects of the inflows from the development on the overland flood flow and resultant afflux from the development's stormwater discharge. This lack of valid assessment of stormwater impacts may result in increased flooding levels experienced by residents upstream of the discharge point for the development.
