# ROWAN VILLAGE - INTERIM ARCHAEOLOGICAL LETTER - ABORIGINAL CULTURAL HERITAGE ASSESSMENT & CULTURAL VALUES ASSESSMENT

# 1. INTRODUCTION

Urbis has been engaged by DevCore Property Group ('the proponent') to conduct an Aboriginal Cultural Heritage Assessment (ACHA) to inform a Planning Proposal to Wagga Wagga City Council for the masterplan redevelopment of the site known as Rowan Village, within the Wagga Wagga South Growth Area, on Wiradjuri Country. Works will be undertaken under a future local Development Application. The lots which comprise the subject area include the following:

- Lot 18 DP 1054800.
- Lots 24, 26, 43, 65 and 66 DP 757246.
- Lot 23 DP 1063399.
- Lots 1 and 2 DP 1171894.

This ACHA is being undertaken in conjunction with a Cultural Values Assessment (CVA) prepared by Kate Waters. The ACHA and CVA aim to achieve the following:

- Investigate, identify and record any Aboriginal cultural heritage values across the site, be they tangible or intangible.
- Provide opportunities to empower Aboriginal community members and Cultural Knowledge
  Holders to be involved in conversations regarding the development of the subject area, the design
  development process, and development of harm mitigation strategies.
- Provide mitigation measures to avoid harm to areas of tangible or intangible cultural sensitivity, including through the provision of design advice to avoid areas of sensitivity.
- Provide a comprehensive understanding of the tangible and intangible cultural values of the site, to inform future interpretation to be guided through consultation.

The preparation of these assessments is still ongoing, and this letter serves as a progress update to accompany the Planning Proposal, to identify works completed to date and works to be completed across the duration of the project.

Urbis have provided initial input into the Indicative Layout Plan (ILP) from an Aboriginal cultural heritage perspective on the basis of preliminary background research & results. This has



recommended the retention of all native vegetation where possible, and the formation of green corridors around extant waterways. These recommendations have been incorporated into the ILP.

# 1.1. SUBJECT AREA LOCATION AND CONTEXT

The subject area is located in Western NSW, within the Wagga Wagga Local Government Area on the traditional lands of the Wiradjuri people and within the catchment of the Wagga Wagga Local Aboriginal Land Council (WWLALC). It is currently zoned as part RU1 Primary Production and part R5 Large Lot Residential.

The subject area encompasses approximately 225.02 hectares (2,250, 227m²) and has frontages to Holbrook Road to the west and Rowan Road to the south. To the north, there is R5 Large Lot Residential zoning and to east, south, and west it is RU1 Primary Production.

The majority of the subject area is in the Redbank Soil landscape. Soils are moderately deep (80-100 cm) and consist of Eutrophic Brown Chromosols on slopes. The soils along the drainage lines consist of Mottled Subnatric Brown Sodosols. There is a high erosion hazard with possible exposures present on site that will need to be checked for isolated Aboriginal objects, i.e Artefacts or Artefact Scatters.

The dominant soil materials consist of brown loam, dull sandy loam, reddish clay, mottled yellowish clay. Due to depths of soils, the subject area contains potential for PADS. Surface finds are also likely to be present.

The site contains approximately 6 ponds (varying sizes), and ephemeral drainage lines (1st, 2nd and 3rd order) associated with Stringybark Creek. The water sources are likely to have higher potential for Aboriginal objects and will need to be closely surveyed. In addition, the subject area is approximately 2 km south-east from Lake Albert catchment area, which is the closest and largest permanent water source in the surrounding landscape.

The native vegetation has been mostly cleared for agricultural purposes with the exception of trees along roads and drainage lines, and minor remnant stands of vegetation within the subject area. The most common tree species for the Redbank Soil landscape are white box, grey box, yellow box and red stringybark.

The subject area is located across the western foothills of the Great Dividing Range and consists of undulating hills. The landscape is very gently inclined adjacent to granite hills.

The land has been used for cropping wheat, barely, cereal, rye and pasture of dryland lucerne. Sheep and cattle have grazed on the steeper parts near the hill and along drainage lines.

A search of the Aboriginal Heritage Information Management System (AHIMS) has been undertaken to inform preliminary assessments, undertaken on 20<sup>th</sup> December 2021. The AHIMS search identified 0 Aboriginal objects and 0 Aboriginal places within the subject area. The search identified one site on the south-western boundary of the subject area is AHIMS ID #56-1-0585. It is a modified ring tree that appears to be in an alignment with a further 3 other modified trees, running to the south-west of the subject area. The site is recorded as being in good condition.



# 2. METHODOLOGY

Urbis submits this letter in anticipation of the completion of the ACHA (as per the program in Table 1).

# 2.1. ABORIGINAL CULTURAL HERITAGE ASSESSMENT

The ACHA process has been completed to Stage 1.3 of consultation. The ACHA is being undertaken in accordance with Part 6 of the *NSW National Parks and Wildlife Act 1974* ('NPW Act'), Part 5 of the *NSW National Parks and Wildlife Regulation 2019* ('NPW Reg') and will adhere to the following guidelines:

- The Aboriginal Cultural Heritage Consultation Requirements for Proponents (Department of Environment, Climate Change and Water NSW, 2010).
- Code of Practice for Archaeological Investigation of Aboriginal Objects in New South Wales (Department of Environment, Climate Change and Water NSW, 2010).
- Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in New South Wales (Office of Environment and Heritage, Department of Premier and Cabinet, 2011).
- The Burra Charter: The Australia ICOMOS Charter for Places of Cultural Significance (Australia ICOMOS, 2013).

Urbis will continue to consult meaningfully with the above RAPs and provide updates to Council as and when required. Meetings will be held at various stages across the consultation process with RAPs and cultural knowledge holders to discuss design, test excavation, methodology, recommendations and approach.

# 2.2. CULTURAL VALUES ASSESSMENT

An Aboriginal Cultural Values Assessment (CVA) is being undertaken to ensure that the broader cultural landscape values and site-specific intangible cultural values are captured and considered within the ACHA process. The CVA methodology involves utilising oral history and cultural mapping techniques during on-Country engagement with cultural knowledge holders (as identified by the Registered Aboriginal Parties) supported by detailed historical and ethnographic archival research. Undertaking a CVA is in line with best practice as reflected in the following guidelines and practice notes:

# 3. **CONCLUSIONS & RECOMMENDATIONS**

Urbis and Waters Consultancy are underway with the ACHA and CVA and will continue to progress these assessments across the duration of the project. As results from these assessments become available, this should be incorporated into the design to ensure areas of cultural sensitivity are avoided where possible and risk of impact is mitigated through design. On a preliminary basis, we conclude that the subject area has high potential to contain both tangible and intangible cultural heritage values which should be protected, conserved, and interpreted where possible, in consultation with the RAPs and cultural knowledge holders.

Urbis support the ILP on a cultural heritage basis, with the provision that this is subject to change pending the results of the ACHA and CVA process, with the preference being to avoid impacts in areas of higher sensitivity.

Urbis recommend that the ACHA and CVA be completed in accordance with the methodologies provided in Section 2.




Figure 1 Regional location of the subject area






Figure 2 Location of the subject area

# Rowan Village Aboriginal Cultural Values Assessment Project: Draft

# Methodology Date Issued: 8/4/22

The proposed approach for the Aboriginal intangible cultural heritage values assessment is to undertake consultation with the identified cultural knowledge holders within a context of historical and ethnographic research into the cultural values of the Project's potential impact areas (see Figure 1) and the wider area in which it is located. The methodology includes undertaking both:

- Consultation with the identified cultural knowledge holders regarding the cultural values of the study area and the specific potential impact zone.
- Historical research in documentary and audiovisual holdings of relevance to the cultural heritage of the study area and the specific potential impact zone.

Sources of historical and ethnographic information will include but are not limited to: archival land records; historical manuscripts; newspaper accounts; site records; and photographic evidence. The documentary and audiovisual holdings of the following institutions would be investigated:

- State Records of New South Wales.
- National Library of Australia.
- State Library and Mitchell Library of NSW.
- Australian Institute of Aboriginal and Torres Strait Islander Studies.
- Charles Sturt University Regional Archives.

Heritage NSW (site and assessment records).

An ethnohistorical overview of the study area and the broader cultural landscape it sits within will be produced
based on the available records. This overview will assist in the identification, contextualisation and assessment of
cultural values within the study area

Consultation with identified cultural knowledge holders is the central element in cultural values assessments. This recognises that consideration of intangible cultural heritage values and the assessment of significance can only occur through consultation with the relevant cultural communities and cultural knowledge holders.

#### **Initial Consultation**

Consultation will be initially undertaken with the Registered Aboriginal Parties (RAPs) to identify those individuals who are regarded as holding cultural knowledge for the Country within which the study area is located. Identified cultural knowledge holders may or may not be RAPs. The identified cultural knowledge holders will be contacted and their participation in the assessment process requested.

### <u>Informed Consent and Cultural Information Management</u>

Cultural information management protocols, including formal consent agreements as required, will be developed in collaboration with the cultural knowledge holders to ensure sensitive information is treated appropriately and the moral rights of cultural knowledge holders are protected.

#### **Interview Process**

The identified cultural knowledge holders who are willing to participate will be interviewed to gather oral histories relevant to the cultural values and cultural landscapes of the study area. Interviews will be conducted with cultural knowledge holders as one-on-one Zoom and face-to-face meetings. Cultural mapping will occur both on-Country and using detailed aerial images and maps. It is recognised that information may be gender sensitive and a male and female consultant will be available to conduct interviews as appropriate.

The assessment of significance of the identified cultural places and landscapes will be undertaken through consultation with the cultural knowledge holders and consideration of the expressed traditional, historical, and contemporary cultural values. Consultation would be undertaken with the cultural knowledge holders in relation to appropriate management of any identified cultural values and cultural items within the potential Project impact zone. The development of mitigation measures for potential impacts on the identified cultural places within the study area will be undertaken collaboratively with the cultural knowledge holders and RAPs to reflect their knowledge and understanding of the cultural values.

# **Review of Draft CVAR**
