**SUBMISSION REGARDING DRAFT FEES AND CHARGES 2020/21 –  
WAGGA WAGGA AIRPORT**

As a Wagga Wagga Airport based private hangar / aircraft owner / pilot / land leaseholder, I write in relation to the proposed 2020/21 Airport Fees and Charges currently open for public consultation. Of particular concern is the continued increase in airport costs associated with my flying activities. While it is accepted that as users we are obliged to contribute to the operation and maintenance of the airport, annual costs should not increase above inflation (CPI) unless there are specific reasons for such increases.

Airport charges levied on the private / recreational sector over the last three years have increased in excess of CPI rates on both an annual and cumulative basis. The attached table analyses the increase of all the airport charges excluding the charges levied against the airlines and airline passengers.

Some of the most significant charge increases (17 – 24% over three years and 5.4 – 6.7% annually for 2020/21) are found in the administrative charges associated with the issue of access cards and driver authorities used to gain access to hangar leases. Charges associated with private aircraft landings and annual landing permits have increased by 6.9% as against a 5.4% increase in the CPI over the three year period and 5.4% annually for 2020/21 as against the CPI of 2.2%.

As there have been no significant changes to the facilities and services provided, it is contended that annual increases should be no more than the annual CPI. The recession resulting from the COVID 19 pandemic is likely to mean a very low CPI rate for the 20/21 FY. Given this impact and that Council has received increases over the annual CPI for the last three years, the increase to be applied on 2019/20 rates for 2020/21 should be no greater than the annual CPI and not the higher rate proposed.

It is appreciated Council will receive substantially reduced airport revenue for 2019/20 and 2020/21 as a result of the greatly reduced activity by the airlines flowing from the COVID 19 pandemic. However, this should not be used as justification for increasing charges on the other user sectors, especially given the vast majority of costs incurred at the airport relate to airline / larger commercial aircraft operations.

I also understand the proposed fees and charges have yet to be considered by the Airport Advisory Committee – one of the fundamental roles of that Committee.
